RE: Ohio's Home Sale Activity Report - April 2006

Ohio's housing market slowed slightly in April - posting a negligible decline in sales activity from the best-ever mark posted during the month a year ago, reports the Ohio Association of REALTORS®.

"The recent increases in mortgage interest rates, combined with higher energy costs may have helped contribute to bring the Ohio housing market back to a more traditional April sales level," said Darlene Breen, President of the Ohio Association of REALTORS®.

Statewide sales of new and existing homes (January-April) totaled 41,138, a 3.3 percent increase from the 39,829 sales posted during the four-month period in 2005.

The state's average sales price (January-April) of \$146,852 nearly mirrors the \$147,707 average posted during the period in 2005. The total dollar volume of \$6 billion is 2.7 percent ahead of the \$5.8 billion posted a year ago.

Sales in April 2006 reached 12,132, a 1.5 percent decrease from the month's record of 12,318 sales posted a year ago. The month's average sales price of \$150,067 is 0.9 percent ahead of last year's \$148,790 average.

The 35,000-member Ohio Association of REALTORS®, the largest professional trade organization in the state, calculates its home sale figures based on statistics provided by the Multiple Listing Services (MLS) throughout Ohio. Participating MLSes include: Ashland, Athens, Cincinnati, Columbus, Centralized Real Estate Information Services, Dayton, Firelands, Greater Portsmouth, Heartland, Knox, Lancaster, Licking, Mansfield, Marion, Northern Ohio Regional Multiple Listing Service, Scioto Valley, Toledo, West Central, Western Regional Information Systems & Technology and Zanesville. The report reflects reported closings by MLSes, including new and existing single-family homes and condominiums/co-ops.

{NOTE: There might be a slight variance between the reported number of sales contained in this release and actual activity in the various markets due to OAR's early reporting requirement. Check with contacts in the particular market.}
